FACULTY SENATE

The Faculty Senate is the primary governance body on the campus.

FACULTY DEFINED FOR GOVERNANCE.

Under the provisions of the ~~Faculty Constitution~~ of the Faculty Senate and for all governance purposes outlined in that constitution, "faculty" is defined as the chancellor, all persons holding faculty appointments, and all persons holding academic staff appointments.

A copy of the ~~Faculty Constitution~~ of the Faculty Senate is in chapter 9 of this Handbook.

MEMBERSHIP.

Eligibility.

All persons holding faculty appointments and all persons holding academic staff appointments are eligible for membership in the Senate.

Election.

Size.

The Senate consists of ~~between 40 and 50~~ no fewer than 35 and no more than 45 elected senators, chairpersons of standing committees, one dean, and the chancellor or the chancellor's designee (the chancellor or a designee are *ex officio* members). The distribution of senators is determined by the number of full-time equivalent faculty and academic staff in the college or other equivalent area.
