### Introduction

The CNR-mandated Summer Field Experience (SFE) offers authentic real-world learning. This hands-on educational program equips you with practical experiences, enhancing your readiness for success in the competitive job market.

### **Course Objectives:**

- Learn basic field techniques in each of the major disciplines.
- Demonstrate field ability.
- Develop awareness of total integrated resource management situations.
- Spend a block of time on concentrated natural resources studies.
- Become familiar with northern flora and fauna.
- Interact with professionals associated with the respective natural resource fields.
- Evaluate field experience in different disciplines for selection of a professional major.

### There are typically three sessions offered:

- **Sessions 1 and 2** are conducted at our Treehaven Field Station located east of Tomahawk in Lincoln County, Wisconsin. Refer to the last page of this packet for directions to Treehaven.
- **Session 3** is offered when enrollment is high and held at the UW-Stevens Point Campus and local field sites. Session 3 is never guaranteed, so do not rely on it being there.

### **Session Placement Criteria –** Which SFE session will you attend?

The following are the selection criteria for the SFE session you will be placed in:

 CNR Core Courses: All applicants must have completed at least NRES 250 and NRES 251 by the end of the spring 2026 semester to be considered. Students who also have completed NRES 150 and 151 will have priority.

### 2. Grade Point Average:

**Required:** A major GPA (including transfer credits) of 2.00 at the end of the fall semester before the summer you plan to attend SFE. This must be maintained through spring to keep SFE seat.

**Considerations:** If your GPA does not meet the requirement by fall, you can still apply. You may have the opportunity to attend the second session of SFE if your GPA improves by spring and if there is space available. GPA will not be a factor in SFE session preference, just acceptance to SFE.

- 3. **Credits**: If the above requirements are met, credits earned may be a factor in determining SFE preferred session but will not guarantee session preference.
- 4. **If you have a specific SFE session requirement needs,** please ensure the following is submitted **before** the SFE application deadline. Please note that while we make every effort to accommodate everyone, it may not always be possible.
  - Relevant Natural Resource Employment OR Military Obligations
    Submit a letter including the following elements:
    - i. Be on letterhead or have an official work signature.
    - ii. State that you will be employed or in training for the rest of the summer if you attend a particular session. State which SFE session you need.
    - iii. Be submitted directly from your employer or military unit to cnrsfe@uwsp.edu prior to the SFE application deadline.
    - iv. Include "SFE Session Consideration for \*Your Name\*" in the subject line.
  - Police Academy, Medical Need, or Significant Life Event
    - i. Submit an email to cnrsfe@uwsp.edu and schedule a meeting with an adviser in the CNR Student Success Center to discuss details.

**Should I apply if I am currently below a 2.0 in-major GPA?** YES! You could still be eligible for the second half of summer once grades come in and would be contacted mid-May!

### Courses

A structured approach to learning takes precedence in all SFE courses. In contrast to a pass/fail system, all classes, including NRES 405: Plant Identification, receive a grade. These courses distinguish themselves through a focus on field laboratory exercises, offering you hands-on engagement with diverse aspects of natural resources field techniques. Led by experienced instructors, courses wrap up with a thorough evaluation on the last day of the week for each topic. The final plant exam is held on the last day of the six-week session. Adding to the academic experience are field trips to local places relevant to the course topics.

# **Faculty and Staff**

Each discipline (forestry, soil, water, wildlife, and plants) will have an assigned faculty. **Teaching Assistants** (TA's) will also be hired to support the faculty by taking care of equipment and supplies, assisting in teaching, driving vehicles, grading exams, and performing other duties assigned by the faculty.

In addition to faculty and TA's, the following positions are part of each SFE:

- **Stockroom Manager**: Responsible for managing and maintaining equipment for all SFE classes and coordinating transportation needs for instructors and students.
- Residence Assistants: Responsible for overseeing housing and social programming at Treehaven. These staff are responsible for enforcing UWSP campus policies, including quiet hours and appropriate student behavior.

# **Application and Registration**

### Step 1: Acceptance

- Electronic applications are due by February 6 at NOON (12:00pm)
- You will be notified within two weeks after the close of the application of your acceptance. Lists will also be available in the CNR SSC. This can be helpful to navigate carpooling options.

### Step 2: Registration

- You will receive notice through electronic permission authorization to register for the **seven** field courses as soon as summer registration opens (end of March 2026).

- Please make sure to register for all SEVEN courses. The CNR deadline to register for SFE classes is March 30, 2026. If you do not register by this date, you will be removed from the program and your spot will be given to a student on the wait list.

### **Tuition and Fee Payments**

To view your current balance, charges, and payments, log in to your accesSPoint account and navigate to the Financial Account/Billing tile. You will also receive an invoice reminder via email. Please continue to check your accesSPoint account and the provided link for up-to-date information.

Please note that any outstanding balances after the e-bill due date will be subject to finance charges of \$75.00 as well as a 1% monthly surcharge. However, if you are enrolled in a CashNet payment plan and making the necessary payments, you will not be subject to administrative fees or finance charges. Refer to the CashNet Billing Dates and Deadlines for the last day to enroll in the plan.

**If you receive financial aid,** please be aware that your aid may be adjusted once you enroll in courses. To receive aid, you must fill out the FAFSA application for the following academic year, using your 2025 tax statements for the 2026/27 application. As the summer term marks the beginning of the 2026/27 academic year, you must use an updated FAFSA.

### Housing

Please Note: Pets are not allowed at either location.

### Treehaven

- Each residential unit at Treehaven can accommodate 4 people and includes sleeping quarters and bathroom facilities. The room is furnished with 2 bunk beds which have 3 twin size mattresses and 1 full size mattress. As the beds are selected on a first come first serve basis, it is recommended to bring full size sheets to ensure a proper fit. Students are provided with a bed, mattress, and a mattress cover, but they will need to bring their own bed linens, pillow, pillowcase, towels, toiletries, etc., as per the packing list.
- Treehaven also has coin-operated laundry facilities available for students to use. These are located off Bear Track Lounge, and each wash and dry cycle costs \$1.00 in quarters only.

### Campus

On-campus housing is available for an estimated \$120 a week. No consistent meal service
is available on campus during the session. It is YOUR responsibility to contact
Residential Living if you need summer housing for SFE.

### Meals

### Treehaven

- The meals for sessions 1 and 2 are full-service and include breakfast, lunch, and dinner, provided by Treehaven from Monday to Friday. However, when you are scheduled to be in the field all day, you may need to prepare a sandwich at the sandwich bar during breakfast and store it in the assigned cooler.
- If you have any food allergies or dietary requirements, please indicate them on your registration form.
- Please be aware that there is no food service available on weekends for students staying at Treehaven. If you don't have a car, you will have limited options for purchasing food from the snack shack in the Bear Track Lounge. These options may include microwavable personal pizzas and sandwiches. The snack shack will be open on Saturdays and Sundays and operates on a self-serve, honor system, with cash or credit card payment at the end of your six-week session.
- Many students prefer to go off-site for meals, either in Rhinelander or Tomahawk, WI.

### Campus

 Please make sure to pack your own lunch and snacks every day, as you may be out in the field and unable to take a break for lunch.

- The dorms (if needed) have a kitchen on each floor, so you can purchase and cook your own food.
- Unfortunately, there are no meal plans available during the summer session. However, residents can purchase PointCASH through the PointCard office. By using PointCASH, you can access a number of dining facilities both on and off-campus during your stay (for more information, please contact the PointCard office.

## Recreation

 The Treehaven stockroom has recreational items such as basketballs, volleyballs and horseshoes you can check out with your student ID. Canoes and kayaks are also available at Treehaven campus free for recreation and fishing.

# Wader Try-Ons (Required)

As a part of your equipment pack, you will receive a pair of chest waders during your check-in at the designated SFE session. To ensure safety, **we do not allow you to bring your personal pair**. Please note the following:

- The size you've indicated on your SFE application will be the size you receive. You are
  required to verify the size that you've mentioned in your application, and we will
  provide men's sizes 6-14 and women's sizes 6-7 for you to try on. If you need a smaller
  or larger size, we will do our best to accommodate you.
- If you're unable to make it to one of the following try-on dates, please let Tim Sattler know at 715-346-4664; CNR.Stockroom@uwsp.edu.
- If you don't show up for the try-on, you will receive the waders according to your shoe size mentioned on your SFE application.
- Please note that the waders you try on might not be the exact make/model you receive.
- When trying on the waders, please try them on as if you were putting them on to go into the water. Do not just try on the boots. Waders are not made size-specific for individuals.

# **Disability Accommodations**

If a student needs academic accommodations during the Summer Field Experience (SFE), it is their responsibility to contact the DRC when they apply for SFE. This will give DRC staff, CNR faculty/staff, and students enough time to identify and establish reasonable accommodations.

Please note that accommodation requests received after March 1st may not be possible to coordinate and implement before departure, especially if you are assigned to Session 1 (the first half of summer).

Furthermore, the College of Natural Resources is committed to providing an inclusive Summer Field Experience, and UWSP is dedicated to the inclusion of students with disabilities. To achieve this, we encourage all students to disclose any potential concerns, whether related to health or personal issues, on their SFE application, and to contact CNR and other campus resources, such as DRC, when applying.

### **Policies**

As part of the University of Wisconsin System, all Summer Field Station locations are subject to the rules and regulations prescribed by the Board of Regents of the State Universities. The operation of Treehaven and Campus is also defined by the following set of regulations.

- There are no overnight facilities for visitors during your session at Treehaven. All short-term visitors must have permission from the field station directors and sign in/out. Treehaven will discuss their specific procedures at orientation.
- Any damage to facilities or loss of equipment at any session shall be paid by the group or person responsible before the end of the session.
- No camping of any kind will be allowed (i.e. trailers, tents, hammocks, etc.)
- SFE students are expected to live on site during the week due to long days, crew dynamics, evening projects, and to study for the plant id exam.
- Individual students and faculty will be held accountable for all equipment checked out to them
- Please help keep Treehaven and Campus grounds clean and picked up at all times.
- There will be no parking allowed by students at Treehaven <u>next to</u> any building except when checking in and out.
- There <u>is long-term parking</u> available for the six weeks. Carpooling is recommended as space may be limited.
- No pets are allowed (i.e. dogs, cats, snakes, turtles, lizards, etc.).
- Other regulations regarding, but not limited to, student conduct, smoking, use of the facilities, and use of the sports equipment will be posted and explained during orientation.
- University regulations regarding alcohol are fully enforced during SFE. Locations
  and alcohol consumption policies will be discussed at the orientation sessions. At
  Treehaven alcohol is allowed in designated areas only, which include the Bear Track
  Lounge and the fire ring right outside the Bear Track Lounge (no drinking is allowed in
  rooms at Treehaven). Violation of this policy can result in removal from the program in
  addition to any university sanctions through the Dean of Students office.

Policies are subject to change and will be reviewed at the session orientations.

### From North:

Take I-39/Hwy 51 to Highway A (Exit #231). Left on Highway A. Continue on Hwy A (east). Hwy A will intersect with Hwy H (Stay on Hwy A, left at stop sign). Go about 2 miles and take a Right on Pickerel Creek. Treehaven is located at the end of the road.

Take Hwy 17 to Hwy A. You will take a Right onto Hwy A. Continue on Hwy A (west) and take a Left on Pickerel Creek. Treehaven is located at the end of the road.

### From South:

Take I-39/Hwy 51 to Hwy A (Exit #231). Right on Highway A. Continue on Hwy A (east). Hwy A will intersect with Hwy H (Stay on Hwy A, left at stop sign). Go about 2 miles and take a Right on Pickerel Creek. Treehaven is located at the end of the road.

#### or

Take Hwy 17 to Hwy A. You will take a Left onto Hwy A. Continue on Hwy A (west) and take a Left on Pickerel Creek. Treehaven is located at the end of the road.

#### CAUTION

When approaching the Intersection of County Road A and County Road H, stay on County Road A. **Do not drive straight onto Drott Road.** This private, gated road leads to Case Industrial property. Please turn around and continue traveling Northeast-bound on County Road A until you see Pickerel Creek Road on your right.
