Victim Advocacy

Who is eligible

Children and Adults with disabilities (and their families) who have experienced a crime, even if it has not been reported.



What services

Know your Rights

As a victim of a crime, you have the right:

- To be treated with fairness, dignity and respect for your privacy.
- To ask for assistance with your employer if necessary, resulting from court appearances.
- To accommodations so you can access victim response services regardless of your disability.
- To restitution and compensation as allowed by law.
- To have the impact of the crime on you considered by the court.
