#### Selection will be based on the following criteria:

- 1) Speaker Qualifications-including lived experience
- 2) Session Topic/Category
- 3) Inclusion of resilience principles and practices
- 4) Promotes evidence based information and best practices
- 5) Demonstrates aspects of effective peer support within community services of mental health and substance use recovery.
- 6) Enhance individual skills to provide more effective personal support.
- 7) Explore innovative applications of peer support.
- 8) Integration of experiences of under-served, marginalized, and/or at-risk populations and communities.
