

General Courses Information

Class Description

This class offers an analysis of crime as an institution, with reference to behavior of those who define, engage in, or become the victims of criminal behavior. The primary objective of this course is to provide students with a general understanding of the field of criminology. This class is a sociology class, which focuses on crime and criminal behavior. The focus of this class will be the examination of criminological theories of crime and criminal behavior. We also will examine criminological research, the history of criminology as a discipline, and the nature, extent, and patterns of crime and criminal behavior. This is <u>not</u> a law, corrections, or policing course; and while we may cover some topics related to these areas, it is first and foremost a theory course.

Course Learning Outcomes

The primary objective of this course is to provide students with a general understanding of the field of criminology.

The courses learning outcomes are:

- 1. Examine and describe the history of criminology as a discipline
- 2. Examine, understand, and describe criminological theories of crime and criminal behavior.
- 3. Examine, and describe criminological research and research ethics in criminology.

Social Science GEP Learning Outcomes

This course meets the GEP Investigation level Social Science requirement. The social science learning outcomes are:

- 1. Explain or apply major concepts, methods, or theories used in the social sciences to investigate, analyze, or predict human behavior.
- 2. Examine and explain how social, cultural, or political institutions influence individuals or groups.

Course Structure

This is a hybrid class which means that some of the class will require students to complete class work online instead of in the classroom. This includes, but is not limited to, videos, assignments, discussions, and exams. All out of class activities and assignments will be submitted on <u>Canvas</u>. I will not accept any assignments completed outside of class in any other form (no paper or e-mail submissions). Approximately one-fourth of the course is online (eight classes) while three-fourths occurs face-to-face.

The online portion of the class will be delivered through the course management system Canvas. You will use your UWSP account to login to the course from the <u>Canvas Login Page</u>. If you have not activated your UWSP account, please visit the <u>Manage Your Account</u> page to do so. All assignments and essays will be submitted on Canvas. Be sure to read ALL Canvas announcements.

A large portion of this class will be devoted to discussion and group activities. Students are expected to have completed the assigned readings prior to coming to class (see schedule of readings attached and on Canvas). Students are expected to contribute their viewpoints and opinions during class discussions. Due to the active role students play in this course, regular attendance is strongly encouraged. While attendance may not be checked daily, excessive absence will negatively affect your final grade. Students are responsible for all information and assignments missed during their absences--including announcements concerning any changes in the course schedule.

Class Assignments

Chapter Quizzes (100 points) There are eight short quizzes (true false/multiple) over each assigned chapter from your textbook. Your top four-chapter quizzes count towards your final grade. All quizzes are due the class after the material is covered. Please see class schedule or calendar for due dates.

Discussions (50 points): There are two required discussions assigned throughout the semester.

Exams (300 points) Three exams will be given during the semester plus a comprehensive final exam. The exams will cover information from class lectures, audio-visual materials, and the readings indicated on the course schedule. You are responsible for all readings even if they are not discussed specifically in class. Dates for exams are on the course schedule. Any changes in exam dates will be posted in the Canvas announcements. Each of these exams is worth 100 points. Students have the option of either dropping the lowest exam score or not taking the final. Exam format will be discussed during class. Makeup exams will only be allowed for *documented* emergencies and health concerns. Please consult with me if this is needed

Essays (100 points): There are seven essay assignments, which will be assigned on online class days throughout the semester. Student are required to complete <u>two</u> of these essays. It is recommended that students complete at least one essay before the midterm.

Grades: Letter grades will be assigned based on the percentage of the possible points that are earned. The point system may be revised. Bring your syllabus and reading schedule to class so you can note any changes.
