Course Description

This course will focus on theory and philosophy along with building student knowledge and skills to create positive partnerships/relationships with young children, families, and outside community agencies. Students will learn the history behind the programs offered to families and how those programs have evolved over time.

Course Learning Outcomes

- 1) Students will be able to relate the theories of Maslow and Epstein to supporting home, school, and community agencies.
- 2) Students will be able to suggest how schools and community agencies can best meet the needs of diverse families.
- 3) Students will be able to explain various programming available to families.
- 4) Students will be able to design an action plan to address the needs and diverse challenges confronting children and families in present day America.

Enduring Understandings

- Students will understand that changes in family structure and socio-economic status affect the home, school, and community agencies.

- Students will understand that Maslow reinforces the importance and significance of basic needs while Epstein underscores practical steps in communication and connecting with families.
- Students will understand that respect for diverse families and the uniqueness of their needs serve as a starting point for supporting homes, schools, and community agencies.

Description of Course Assignments

Community Resource Guide

30 pts.

In small groups, students will research what programs/resources are available for families within a specific community. A brochure or distributable flyer will be created to include high quality childcare options, Head Start locations, county specific programs, after-school programming, and parenting resources (counseling, classes, support groups, food assistance, etc.) that can be distributed to classmates and schools. *This is a signature assessment and requires a score of 80% or better.

Group Facilitation **30pts.**

Each group will serve as discussion facilitators to start a class for approximately 20 minutes. The discussion should focus on specific course content and readings as related to the class period. A rubric is available on CANVAS.

Sesame Street in Communities Activity **20pts.**

In small groups, students will select a topic from the Sesame Street in Communities website that directly connects to course content. Once a topic is selected, students will develop an outline describing a lesson they would develop to address the topic within the early childhood classroom.

Community Agencies Interview **40pts.**

Students will interview someone from either a place of worship, community library, community place for children (i.e., children’s museum), or a state/local agency (i.e., police department, health and human services, parks and recreation, etc.). Questions should focus on type, services, challenges, and relationship between the agency and the home and schools. Specific questions will be generated in class and a rubric is available on CANVAS.

Relationship Action Plan **40 pts**

Students will reflect on course readings, class discussions, and complete additional research to develop an action plan for building relationships with families and the community either individually or with a partner. Actions plans will address the following: 1) diverse family and community characteristics; 2) ways to support and engage families and the community; and 3) ways to include and educate families and the community about child development and learning. A rubric is available on CANVAS. *This is a signature assessment and requires a score of 80% or better.

Engaged Book Reflections **30 pts.**

Students will self-select at least two reflection question from each section of the Engaged text to thoroughly address.

Pointer Points **Pass/Fail**

This course requires a minimum of four *Pointer Points* in leu of practicum hours. This is a course requirement and must be meet to earn a passing grade. Please refer to handout for additional information and opportunities regarding *Pointer Points*. As a reminder, *Pointer Points* can only be earned for activities completed outside of regular class requirements and without remuneration.

Assignment Criteria/Late Work

Quality: Papers must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

Originality: All work must be original for this class. Work done for other classes will not be accepted. Information that is not the student's original work must be documented by citing the source using APA 7th edition.

Submission Format: Unless otherwise noted, all assignments must be submitted **electronically** on CANVAS uploaded in student folder **on or before the due date by 10:00am**. Each assignment must be submitted as a single WORD document. *Each assignment must have the student's name, date, and course number.*

Timeliness/Late Work: One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late. A failing grade, or an incomplete will be given for noncompletion. Any and all course work for the semester is due at the beginning of the courses' scheduled final; any work submitted after this time will not be accepted.

Attendance

Attending class will likely be the single most important factor in determining your performance and grade in this course, so plan to attend every class. Your attendance and participation is essential. Collaboration with your peers outside class is strongly encouraged. All students are expected to read the assigned material before each class session. Students may be asked to discuss textbook and lecture material in small groups.

Students' final grade will be dropped in the event of excessive absences. On the fifth absence ("excused" or "unexcused" - I do not differentiate between the two), a student's final grade will be dropped one half letter grade (for example, A- to B+) At every second absence thereafter (on the 5th, 7th, 9th, 11th, etc. total absences) a student's letter grade will be dropped one half letter grade further (for example, on the 5th absence the earlier mentioned A- will drop to a B+. On the 7th absence that B+ would drop again to a B. On the 9th absence the original A- will drop to a B-.) Please note that failure to complete the assigned activity for any online class will be counted as an absence and participation points for that session will not be earned.

Accommodations can be made for absence(s). If you will be missing class, before or within 1 day of your absence you must request an alternative assignment that you can complete and hand in or your absence will count as one of your four unpenalized ones. If you feel ill, please err on the side of caution and stay home.

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:
 - (a) Seeks to claim credit for the work or efforts of another without authorization or citation;
 - (b) Uses unauthorized materials or fabricated data in any academic exercise;
 - (c) Forges or falsifies academic documents or records;
 - (d) Intentionally impedes or damages the academic work of others;
 - (e) Engages in conduct aimed at making false representation of a student's academic performance; or
 - (f) Assists other students in any of these acts.
- (2) Examples of academic misconduct include, but are not limited to:
 - Cheating on an examination
 - Collaborating with others in work to be presented, contrary to the stated rules of the course
 - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another
 - Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas
 - Stealing examinations or course materials
 - Submitting, if contrary to the rules of a course, work previously presented in another course
 - Tampering with the laboratory experiment or computer program of another student

- Knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.
