Course Description

This course examines the Preschooler/Kindergartener as a whole child. It will examine their very specific physical, language, social-emotional, and cognitive growth and needs; and how such needs can be met in the early childhood classroom. This course also requires a minimum of 10 practicum hours in either a 4K/preschool setting or a kindergarten classroom. The course specifically examines how:

- Young children fit into the theories of Piaget, Vygotsky, Gardner, Montessori, and Dweck
- To plan intentionally and developmentally appropriate curricula in expressive arts, language arts, mathematics, science, social studies, and health education.
- Assessments can be integrated authentically in the classroom.

- 1) Relate the stages of young child development to learning theories.
- 2) Apply knowledge of child development to designing education environments that meet the needs of developmentally diverse learners.
- 3) Apply principles of early childhood education to prepare learning activities.

Practicum Reflection

30 pts

Prepare a formal paper summarizing student practicum experiences. This paper should be a minimum of two pages and should be reflective in nature as students look back on their experiences, observations, and course readings. Summary instructions and rubric are available in CANVAS.

Unit Plan 100 pts.

This assignment involves the preparation and implementation of a thematic, developmentally appropriate learning unit within the kindergarten classroom using the framework of Understanding by Design (UbD). Lessons may include literacy, math, social/emotional, gross motor, fine motor, read-aloud stories, sensory exploration, science, social studies, health education, and expressive arts. Unit plan specifics and rubric available in CANVAS.

Recorded Teaching Lesson

30 pts.

Choose one lesson from the unit plan to teach to an imaginary group of students. This should include 20 minutes to teach the lesson and complete an activity. Provide an electronic copy of the lesson plan and recorded link by the due date. A rubric for this assignment is available in Canvas.

Assignment Criteria/Late Work

Quality: Papers must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

Originality: All work must be <u>original for this class</u>. Work done for other classes will not be accepted. Information that is not the student's original work must be documented by citing the source using APA 7th edition.

Submission Format: Unless otherwise noted, all assignments must be submitted electronically on CANVAS uploaded in student folder on or before the due date by 12:00pm. Each assignment must be submitted as a single WORD document. Each assignment must have the student's name, date, and course number or no grade/feedback will be provided.

Timeliness/Late Work: One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late. A failing grade, or an incomplete will be given for noncompletion. Any and all course work for the semester is due at the beginning of the final course day; any work submitted after this time will not be accepted. You have 3 days from receiving feedback to revise and resubmit any assignment (excluding late assignments) except for the final unit plan.

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:
- (a) Seeks to claim credit for the work or efforts of another without authorization or citation;
- (b) Uses unauthorized materials or fabricated data in any academic exercise;
- (c) Forges or falsifies academic documents or records;
- (d) Intentionally impedes or damages the academic work of others;
- (e) Engages in conduct aimed at making false representation of a student's academic performance; or
- (f) Assists other students in any of these acts.
- (2) Examples of academic misconduct include, but are not limited to:
 - Cheating on an examination
 - Collaborating with others in work to be presented, contrary to the stated rules of the course
 - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another
 - Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas

- Stealing examinations or course materials
- Submitting, if contrary to the rules of a course, work previously presented in another course
- Tampering with the laboratory experiment or computer program of another student
- Knowingly and intentionally assisting another student in any of the above, including
 assistance in an arrangement whereby any work, classroom performance, examination
 or other activity is submitted or performed by a person other than the student under
 whose name the work is submitted or performed.
