Course Information

Course Description: Interdisciplinary course that provides a foundation for the development of a personal and professional leadership style grounded in leadership theories, as they pertain to socio-cultural, political, as well as pedagogical and ecological issues. Leadership discourses and discussion will be reflective of the influence of the social locations and identities of the actors as well as the dynamics of power, resistance, powerlessness, and efforts to claim citizenship and justice from the grassroots and up. Through exposure to recognized leaders in society, ecology, education, and other fields, students will postulate what leadership principles resonate with their area of work and study. Engage in interdisciplinary analyses of leadership theories and philosophies and examine the complex ethical and professional responsibilities within professional and community relationships.
