## I. Purpose and Description of Course:

- Education 713 students will engage in activities to connect content from other special education courses into comprehensive special education practice. Students will review the administration, scoring, and interpretation of tools used in individualized assessment. They will use information from an IEP meeting to develop a full annual IEP. In addition, students will develop skills in conducting IEP meetings. Students will also participate in activities and assignments to further their skills in the instructional process culminating in a comprehensive learning map for one specific skill for one specific student. All written work and oral communication in Education 713 fits the backbone of the special education profession. Successful completion of this course will require 12 hours of clinical experiences (practicum) working with students with disabilities under the supervision of a special education teacher.

## II. Student Learning Outcomes:

- Students will write an IEP according to state requirements.
- Students will use backwards design to plan evidence-based instructional activities and assessments that will guide an individual student with an IEP to meet a specific IEP goal.
- Students will deepen their understanding of a self-selected area of special education by researching, planning, and preparing a mock professional development offering.
- Students will select and adapt evidence-based instructional strategies to individualize learning for students with exceptionalities.
- Students will demonstrate strategies for engagement with those who support students with disabilities, including families, other educators, related service providers, and community agencies.

## VIII. Academic Expectations and Standards

### Student Academic Disciplinary Procedures

#### **UWSP 14.01 Statement of principles.**

The board of regents, administrators, faculty, academic staff and students of the university of Wisconsin system believe that academic honesty and integrity are fundamental to the mission of higher education and of the university of Wisconsin system. The university has a responsibility to promote academic honesty and integrity and to develop procedures to deal effectively with instances of academic dishonesty. Students are responsible for the honest completion and representation of their work, for the appropriate citation of sources, and for respect of others' academic endeavors. Students who violate these standards must be confronted and must accept the consequences of their actions.

#### **UWSP 14.03 Academic misconduct subject to disciplinary action.**

(1) Academic misconduct is an act in which a student:

- (a) Seeks to claim credit for the work or efforts of another without authorization or citation;
- (b) Uses unauthorized materials or fabricated data in any academic exercise;
- (c) Forges or falsifies academic documents or records;
- (d) Intentionally impedes or damages the academic work of others;
- (e) Engages in conduct aimed at making false representation of a student's academic performance; or
- (f) Assists other students in any of these acts.

(2) Examples of academic misconduct include, but are not limited to: cheating on an examination; collaborating with others in work to be presented, contrary to the stated rules of the course; submitting a paper or assignment as one's

own work when a part or all of the paper or assignment is the work of another; submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas; stealing examinations or course materials; submitting, if contrary to the rules of a course, work previously presented in another course; tampering with the laboratory experiment or computer program of another student; knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.

## **XX. Confidentiality:**

- Learning requires risk-taking and sharing ideas. Please keep your classmates' ideas and experiences confidential outside the classroom unless permission has been granted to share them.

## **XXI. Religious Observances**

### XXIX. Assignments:

- The course requirements are designed to help you foster proficiencies, demonstrate competence or provide evidence of the above outlined standards and student learning outcomes. **Please note that the IEP Assignment and Mock Professional Development Conference Proposal are Signature Embedded Assessments and must be turned in in order to pass this course regardless of your total points earned or final percentages. In other words, failure to complete them will result in course failure. Do not submit google doc links for your assignments.** More detailed assignment descriptions can be found in Canvas.
  - **Weekly Learning Activities:** Throughout this course you will be expected to complete learning activities corresponding to textbook chapters. Types of tasks may include communicating via email, completing basic internet searches, downloading and uploading documents to Canvas, reading documents online, viewing online videos, participating in online discussions, completing tests online, participating in asynchronous online discussions. You will earn points for participating in and submitting various activities. Although the activities are due Sundays, you may work ahead and complete them/turn them in early.
  - **Annual IEP:** You will develop an annual IEP. This assignment requires specific forms and peer feedback. It helps you practice professional writing skills that you will be required to use as a special education teacher and is representative of one way that you will collaborate with families, other educators, related service providers, individuals with exceptionalities, and personnel from community agencies in culturally responsive ways to address the needs of individuals with exceptionalities across a range of learning experiences.
  - **Learning Map:** You will complete a comprehensive learning map designed for the instruction of one specific IEP goal including all steps of shaping toward the final desired criteria. The learning map requires you to use backwards design in order to plan a series of lessons to meet IEP benchmarks, short term objectives, and a goal.
  - **Comprehensive Portfolio Artifact Reflection:** During the final academic term of their program, master's degree candidates must submit a comprehensive portfolio. This portfolio will include artifacts and reflections from coursework in the program. It allows students to develop an organized collection of work and thinking that demonstrate content mastery, growth, and evidence that candidates are self-directed and reflective practitioners. (Master of Science in Education Comprehensive Portfolio Guidebook, p. 3) [Master's of Education Student Resources](#) (Note: If you are currently seeking your first teaching license, you do not need to complete this assignment.)
  - **Mock Professional Development Conference Proposal:** Write up a mock proposal to give a 50 minute presentation at a special education conference. Researching, planning, and preparing a professional development offering in an

area of your expertise/interest will help you to inform special education practice, to engage in lifelong learning, and to advance the profession.

- **Final Exam:** You will research a topic in the field of special education and write a paper synthesizing your findings.
- **Practicum Assignment:** This course requires a 12 hour practicum with a special education teacher providing instruction to a student with an IEP.
