- **Week 1: Introduction to English Language Arts**
 - Participants will gain an overview of the six language arts and how language is the foundation for development of all six language arts. We will start to discuss the interconnectedness of the six language arts and the importance of explicit language arts instruction.
- **Week 2-Week 3: ELA in the Content Areas**
 - Embedding English Language Arts instruction throughout your day provides a meaningful context for student learning. In this module, we will look at how to embed ELA instruction in other content areas through intentional vocabulary instruction as well as pre, during, and post-reading activities.
- **Week 4-Week 5: Reading**
 - Students will review evidence-based reading instruction and apply the concepts in the development of an interactive read aloud.
- **Week 6-Week 7: Writing**
 - Participants will review evidence-based writing instruction and apply the concepts while creating a series of three lesson plans for writing.
- **Week 8: Unit Design: Planning for Integration**
 - In the final week of the course, you will compile your course assignments and create an additional activity to complete a content area unit plan around a Science or Social Studies topic.

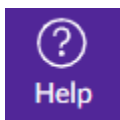

Student Academic Disciplinary Procedures

UWSP 14.01 Statement of principles
