TEXTS: The primary text for this course is <u>Public Finance and Public Policy</u>, fourth edition, by Jonathan Gruber. Additional readings may be assigned throughout the course. Any additional required reading will be announced in class.

COURSE DESCRIPTION: This course provides an introduction to Public Economics topics. In broad terms, Public Economics is a microeconomic field concerned with government taxation, spending, and regulation. Specifically, we will address: 1) positive government actions which can enhance efficiency; 2) positive government actions which can enhance equity; and 3) optimal taxation policies designed to minimize efficiency losses and/or improve equity.

HOMEWORK AND PARTICIPATION: There will be a number of homework assignments and group discussion assignments throughout the term. Active participation and completion of the homework assignments will collectively count for 25% of your final grade. Assignments will be announced in class at least one class meeting in advance.

EXAMINATIONS: There will be three exams in the class, including the final exam. Each exam will count for 25% of your final grade. The exams will be held on the following dates:
