Course description

Exploration of conceptual models for organizational capacity analysis, programmatic evaluation, and conflict resolution as they relate to the role of natural resource professionals as leaders within their own organization and among the broader community of stakeholders. The course places specific emphasis on developing skills in negotiation, facilitation, budget, and strategic planning relevant to professionals working in natural resources organizations.

Learning outcomes

By the end of the course, students will be able to:

1. Assess leadership skills and styles in natural resource management
2. Apply communication strategies to natural resource management issues
3. Develop a data and fiscal management plan that supports the mission and operation of an organization.
4. Create a plan for organizational/programmatic improvement

Course details

The course will use Canvas, UW-Stevens Point's online course management system. For online meetings, we will use Zoom. We will meet asynchronously online Sept. 6 – Dec. 15, 2022. There are four synchronous meetings scheduled from 6-7:30pm on the following dates: 9/14, 10/12, 11/9 and 12/7). Additional details will be shared in Canvas—you will need a microphone and camera to participate in these meetings.

Facilitator's Assumptions

It is assumed that students enrolled in this course are

- responsible adults who view learning as a participatory sport versus a spectator sport
- self-motivated professionals aware of their personal, professional, and academic needs
- the driver of the learning experience gained in this course

The facilitator will direct the course to provide structure and support for optimized learning.

Required Readings

There are no required textbooks for this course. All required readings are posted in Canvas, the course management software program used for this course.

Attendance and Participation

There are several moving parts in each week of this course, so it is highly recommended that you log in to Canvas at least once a day during the weekdays. At a minimum, you'll want to access the course 3x per week. Regular participation and engagement in the course are expected, and so I will be very present in the course to ensure that you are active, and that you have the support you need to be successful. If I do

not “see” you, I will reach out to you. If you are having issues and need to step out for a few days/week, please let me (and your classmates know) if it will affect your contributions to class. Communication is KEY!

Discussions and Assignments

Due to the nature of the online environment, it is expected that you consistently contribute to the discussions during the course. While not written in stone, online discussions flow best when you begin your initial comments earlier than the deadline. Remember you are also expected to respond to your peers and or myself when comments/questions are posted. Not always but not all my questions are rhetorical 😊 Remember, we all learn from one another. A good rule of thumb is to post your initial post 2-3 days after the start of that discussion (Wed-Thurs), and respond to your peers by Saturday-Sunday. All discussion post deadlines are Sunday’s.

Professionally presented papers are clear and cohesive, have been checked for spelling and grammatical errors, are double-spaced, and are submitted by the deadline to earn full credit. If you run into an unforeseen issue or just get waylaid by schedules let me know. There is flexibility (to a point).

Grading and Evaluation

Grading System

All work be done in a progressive manner to allow me to give continual feedback for improvement. This feedback may come in the form of engaging in the discussions and project work as well as assignments submitted. It is expected that students incorporate feedback for improvement for their future work. Grades will be assigned for the each of the projects: 30 points for each project, and holistic work (20 points) for your participation in class which will be evaluated against the holistic grading rubric for the final grade.



Integrity

Integrity refers to adherence to consistent moral and ethical principles. A person with integrity is honest and treats others fairly.

Collegiality

Collegiality is a cooperative relationship. By being collegial you are respecting our shared commitment to student education through cooperative interaction. This applies to all involved in the process: students, staff, faculty, administration and involved community members. Civility

Timeliness

Timeliness is the habit of performance of tasks and activities, planned in a way that allows you to meet deadlines. This increases workplace efficiency and demonstrates respect for others' time.

Respect for Property

Respect for property is the appreciation of the economic or personal value an item maintains. Maintaining this respect can both reduce costs (increase the operable life of supplies and equipment) as well as demonstrate respect for others' rights.

Communication

Professional norms in communication require that you demonstrate the value of your colleagues, students, professors or others. The use of appropriate tone and vocabulary is expected across all forms of communication, whether that communication takes place face to face, in writing or electronically.

Commitment to Quality

Quality is the ability to meet or exceed expectations. By having a commitment to quality, we intend to provide a learning environment that is conducive to learning. Intrinsic to this commitment to quality is defining expectation (committed to in a syllabus through learning outcomes), implementation (with quality control in place) and assessment (where meeting of learning outcomes is determined).

Learning is a lifelong process. By being committed to learning you are providing a model for all to follow. This model is not only professor to student but involves all combinations of people within our university and broader community

Online Academic Etiquette

We like to make some suggestions for good "digital citizenship" moving forward. First, please be aware that lectures (including your verbal questions, chats, etc.) are being recorded. If you don't want your video feed or image captured in a recording, then it is totally acceptable to keep your video feed "off". Verbal questions end up in a transcript. Chat-based statements also are recorded. Both will have your name associated with them and are part of the recorded lecture. This isn't that different from when you raise your hand to ask a question in class EXCEPT that there is now a recording associated with it. So, please take extra care to ask questions, answer questions, and use chats in a respectful way.

Additionally, please keep in mind that your instructor's lectures are their intellectual property. In order to maintain a safe learning environment for everyone (so that students can ask questions freely and so that faculty can deliver material freely), it is critical that you DO NOT share Zoom links/passwords to lectures/discussion meetings OR Zoom recordings of the class with anyone outside of our class. Misuse of chats, sharing these links/passwords, or recordings will be considered a disruption of the classroom as a learning environment. Disruptions (even digital ones) could impact your grade in a negative way.
