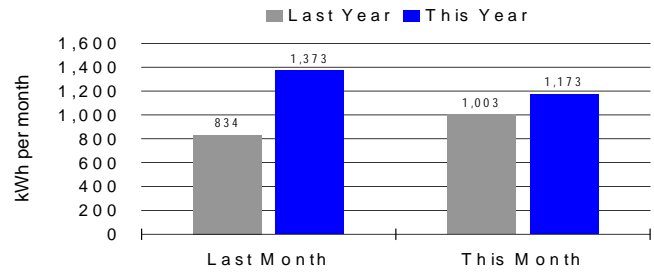

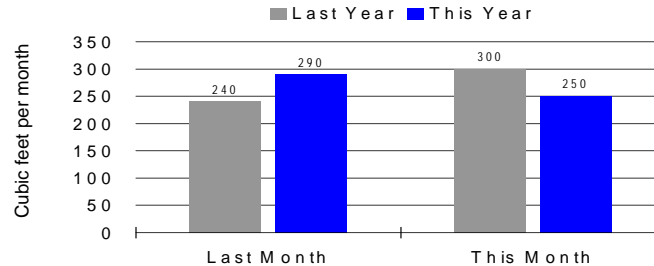

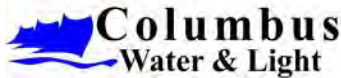
Electric Usage Comparison

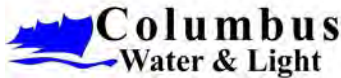
Electric Usage Comparison

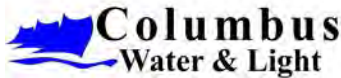
Electric Usage Comparison

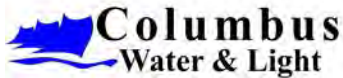
Electric Usage Comparison

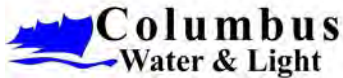
Electric Usage Comparison

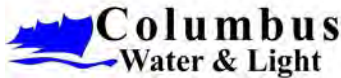
Electric Usage Comparison

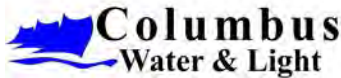
Electric Usage Comparison

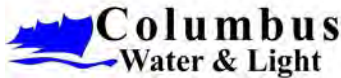
Electric Usage Comparison

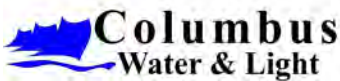

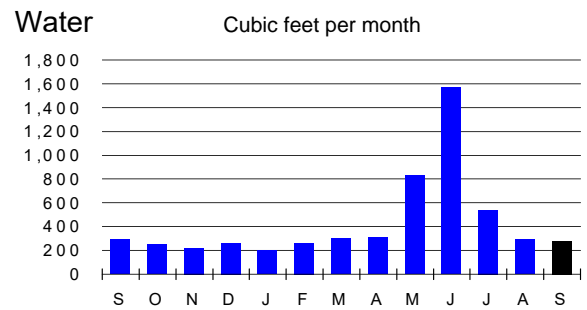
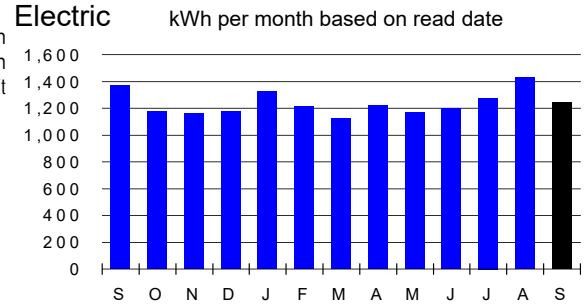
