

UW-Extension Specialists – Interpret University research to help people make informed decisions for their communities. Share experiences from other communities with similar challenges.

UW-Extension Basin Educators - Provide leadership for science-based educational programs regarding land and water resources.

Department of Natural Resources (DNR) Lake Management Coordinators – Administer lake and river grants, water quality monitoring, water resource planning and management activities, and educational programs.

DNR Water Management Specialists – Administer state water regulation permit programs related to activities in the water through public education and enforcement. Provide comment regarding county shoreland ordinances and related decisions.

Zoning Administrators – Administer county shoreland, comprehensive, sanitary and related ordinances through permit programs, public education and enforcement.

Wisconsin Association of Lakes (WAL) – Preserve and protect lakes, their watersheds and ecosystems, promote public policy, advance education and promote local leadership.

Regional Planning Commissions – Assist with mapping, water classification and shoreland ordinance drafting.

To accomplish this goal, state, county, and local government agencies, as well as schools, businesses, volunteer organizations, and private individuals, effectively joined forces. Today, RSVP conducts workshops for property owners, realtors, and landscapers to teach sound shoreland management, hosts annual public tours of shoreland restoration demonstration sites on both public and private properties, provides cost sharing for restoration projects, certifies businesses in shoreland restoration, and offers the services of a Shoreland Restoration Specialist to riparians and businesses.

The number of shoreland dwellings has more than doubled on lakes north of Highway 29 from 1965 to 1995 (Northern Initiatives study). This presentation explains how this development has affected the water quality and wildlife habitat of our lakes and streams and provides examples of what communities are doing to protect their lakes for future generations.

Description for issues 1, 2 and 3:
