**Addendum to Dress Code Policy
 for Facility Services
 Sponsored Events**

1. Costumes/Dress may not have parts that interfere with or distract from the daily requirements of an individual’s responsibilities. Individual’s costumes/dress must not restrict movement or vision.
2. Costumes/Dress may not promote violence or be suggestive in nature. This includes accessories or props that could be used as a weapon or would be deemed unsafe.
3. Costumes/Dress may not be demeaning to any ethnic group, race, religion, nationality, handicapping condition, or individual (staff or student) at UWSP.
4. The identity of the individual must not be hidden and the individual Facility Services name badge must be visible at all times.
5. Costume/Dress may not contain or display inappropriate language or graphics.
