Pre-Law Program at UW-Stevens Point

The pre-law program at UWSP is not a set curriculum but instead is simply a recommend list of courses. Most UWSP students who attend law school will take some of the recommended courses, but typically will not take all of them. The most popular pre-law courses are: POLI 211 Practical Law, POLI 212 Law and Legal Systems, POLI 330 or 331 Constitutional Law, and POLI 335 Law and Society. Many students also take PHIL 121 as preparation for the Law School Admissions Test (LSAT).

PRE-LAW KEY FACTS:

- 79% of UWSP Seniors who applied to law school were admitted to at least one law school.
 - 51% of UWSP graduates who applied to law school within 1-3 years were admitted to at least one law school.
 - 44% of UWSP graduates who applied to law school over 3 years after graduation were admitted to at least one law school.
- Approximately 2/3ds of those admitted to law school are Political Science Majors.
- Approximately 78% of those admitted to law school had academic majors in the College of Letters and Science.
- Non-COLS LSAT score (average): 152 (52nd percentile on 2015 test)
- COLS LSAT score (average): 154 (60th percentile on 2015 test)
