Course Description

This course examines the types, settings, challenges, and issues facing specific programs; including Early Childhood (infant/toddler, preschool, and kindergarten), childcare, Head Start, Early intervention, and others. This course also explores brain-based, play-based learning environments, childcare regulations, poverty, and diversity.

- 2. STUDENTS WILL DESCRIBE AN APPROPRIATE LEARNING ENVIRONMENT BASED ON CLASS READINGS AND DISCUSSIONS, WITH A KNOWLEDGE OF THEORETICAL PERSPECTIVES ON CHILD DEVELOPMENT.**
- 3. STUDENTS WILL OBSERVE/DESIGN SOCIAL PROGRAMS BASED ON SOCIAL TRENDS, NEEDS, AND DIVERSE CHALLENGES CONFRONTING CHILDREN AND FAMILIES IN PRESENT DAY AMERICA.**

Standards

This course will use both NAEYC (National Association for the Education of Young Children) and inTASC (Interstate New Teachers Assessment and Support Consortium) standards to connect learning to real-life teaching and application.

Description of Course Assignments

Childcare/Early Childhood Observations 30pts.

Students will complete one observation (45-60 minutes) and complete the necessary form given by the instructor and write an observation summary paper.

Interview with Childcare Provider 50pts.

Students will contact a director or assistant director of a childcare facility and interview them over the phone or virtually. Students will receive a list of questions along with a recording sheet. After the interview is complete, students will use their notes to create a Canva presentation (about 5 minutes long) highlighting their discoveries.

Book Review Journals 50 pts.

Students will read one of the approved play-based books and complete the guiding questions and/or journal prompts.

Program Resource Guide 30 pts.

In small groups, students will research what programs are available for families within a community. Together the students will develop a resource guide and distribute to the class.

W14 Discussion Board 10 pts

Week 14 will be held virtually; students will be expected to post an initial discussion post (worth 6 pts) and respond to at least one of their peers (worth 4 pts).

Playful Learning= School Readiness Project 100 pts.

Students will create an infographic and present to the class on the topic of promoting play in young children. Students will be required to research 10 scholarly articles, 10 websites, and 10 newspaper, journal, or magazine articles to complete their infographic.

Attendance & Participation 30 pts (1pt. for each class)

You are required to attend each class period and come prepared to discuss readings and collaborate with your peers on course activities. See attendance information further down.

Attendance

Attending class will likely be the single most important factor in determining your performance and grade in the course, so plan to attend every class. In most class meetings you will have at least one project, exercise, test, and/or discussion that will impact your grade, and your class discussions will count toward participation. The relationship between attendance and achievement in education has been extensively documented in peer-reviewed research. ***I am not able to re-teach the material to you in the event that you are absent, but you can ask a classmate to share notes. Any exceptions to the attendance policy should be confirmed in writing.***

Attend all your classes regularly. We do not have a system of permitted "cuts." If you decide to drop a class, please do so using myPoint or visit the Enrollment Services Center. Assignment Criteria/Late Work

Quality: Papers must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. More than one grammatical/mechanical error per page (on average) does not constitute "A" work. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

Originality: All work must be original for this class. Work done for other classes will not be accepted. Information that is not the student's original work must be documented by citing the source using APA 7th edition.

Submission Format: Unless otherwise noted, all assignments must be submitted **electronically** on CANVAS uploaded in student folder **on or before the due date by 9:30am**. Each assignment must be submitted as a single WORD document. The top page of each paper must have name, date, course number, and assignment name.

Timeliness/Late Work: One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late (see rubrics). A failing grade, or an incomplete will be given for noncompletion.

UWSP 14.03 Academic misconduct subject to disciplinary action.

- (1) Academic misconduct is an act in which a student:
 - (a) Seeks to claim credit for the work or efforts of another without authorization or citation;
 - (b) Uses unauthorized materials or fabricated data in any academic exercise;
 - (c) Forges or falsifies academic documents or records;
 - (d) Intentionally impedes or damages the academic work of others;
 - (e) Engages in conduct aimed at making false representation of a student's academic performance; or
 - (f) Assists other students in any of these acts.

- (2) Examples of academic misconduct include, but are not limited to:
 - Cheating on an examination
 - Collaborating with others in work to be presented, contrary to the stated rules of the course
 - Submitting a paper or assignment as one's own work when a part or all of the paper or assignment is the work of another
 - Submitting a paper or assignment that contains ideas or research of others without appropriately identifying the sources of those ideas
 - Stealing examinations or course materials
 - Submitting, if contrary to the rules of a course, work previously presented in another course
 - Tampering with the laboratory experiment or computer program of another student
 - Knowingly and intentionally assisting another student in any of the above, including assistance in an arrangement whereby any work, classroom performance, examination or other activity is submitted or performed by a person other than the student under whose name the work is submitted or performed.

Students suspected of academic misconduct will be asked to meet with the instructor to discuss the concerns. If academic misconduct is evident, procedures for determining disciplinary sanctions will be followed as outlined in the [University System Administrative Code, Chapter 14](#).
