## Course Description

Using the Understanding by Design (UbD) framework, this course explores “hands-on” activities in art, music, creative movement, and creative dramatics in early childhood classrooms. Integration of STEM and the implications of specific theories (Piaget, Vygotsky, Gardner, Erikson, and Reggio Emilia approach) are discussed. Findings from brain research in early childhood classrooms, impact of technology, globalization, diversity, and intentional play are also integrated in the course. Practicum experience in an early childhood setting is an essential component of this course.

## Course Learning Outcomes

- 3. STUDENTS WILL UNDERSTAND THE CENTRALITY OF STEM, GLOBALIZATION, AND DIVERSITY/ANT-BIAS PRACTICES IN EARLY CHILDHOOD CLASSROOMS UNDERSCORES DEVELOPMENTALLY APPROPRIATE PRACTICES.**

## Description of Course Assignments

### **Art Lesson** **20pts.**

Students will work in groups of 3-4 using the SOE Professional Program Lesson Plan Template to prepare and present a lesson in art at the second grade level.

### **Creative Dramatics Lesson** **20 pts.**

Students will work in groups of 3-4 using the SOE Professional Program Lesson Plan Template to prepare and present a lesson in creative dramatics at the 4K/Preschool level.

### **Music Lesson** **20 pts.**

Students will work in groups of 3-4 using the SOE Professional Program Lesson Plan Template to prepare and present a lesson in music at the first grade level.

**Movement Lesson** **20 pts.**

Students will work in groups of 3-4 using the SOE Professional Program Lesson Plan Template to prepare and present a lesson in creative movement at the kindergarten level.

**Curricula Supports** **20 pts.**

As part of the Preclinical experience in this course, each student will collaborate with the lead teacher at their placement to prepare/re-design and update specific learning centers within the classroom. The complete the assignment students will complete the curricula support form (this will describe your ideas, rationale, standards, materials, and reflection). Students will need to meet with the lead teacher to discuss the form before setting up the center and also meet with the lead teacher after to discuss the learning outcomes.

**Group Final Unit Plan** **100 pts.**

Students will use the SOE Professional Program Lesson Plan Template to prepare an extensive unit plan on the theme “friendship” in at least five curricula areas (art, music, movement, creative dramatics, literacy, math) at the kindergarten, first grade or second grade level. Students should integrate diversity and STEM within the entire unit plan.

**Preclinical Journal** **40 pts.**

Students will keep an electronic journal on the learning centers in their preclinical classroom. The weekly journal entries will feature descriptions of centers that include art, movement, music, and creative dramatics. Journal entries will be reviewed each week in class.

**Lesson Plan Implementation** **40 pts.**

Students will use the SOE Professional Program Lesson Plan Template to plan and present an activity in art to learners within your preclinical classroom (4K/Preschool level). This lesson plan MUST be approved by the Professor and the Lead Teacher before implementation.

**Preclinical Summary** **40 pts.**

Students will write a 2-3 page summary of their preclinical experience. Specific questions will be provided.

**Expressive Arts Focus Summary** **40 pts.**

Students will prepare a formal paper on a chosen curriculum in Expressive Arts based on their preclinical journal entries. The paper will explore the impact of this curriculum on learning experiences in our preclinical classroom. Students will identify curriculum and provide theoretical rationale of the significance of this curriculum in early childhood. Students will then summarize how the curriculum was set up and utilized, while also suggesting ideas to enrich the curriculum. Students will then reflect on what they learned while keeping a weekly journal on learning centers.

**Attendance & Participation** **30 pts (2pts. for each class)**

You are required to attend each class period and come prepared to discuss readings and collaborate with your peers on course activities. You are also expected to attend your preclinical placement two hours each week. See attendance information further down.

## Assignment Criteria/Late Work

**Quality:** Papers must demonstrate scholarship and higher-level thinking skills. Ideas must be clearly stated, using inclusive language. Statements must be supported by concrete examples and reliable references. Paragraphs must be logically organized and coherent with correct spelling and grammar. More than one grammatical/mechanical error per page (on average) does not constitute “A” work. Overall appearance must be polished and professional. Papers must be word-processed and double-spaced.

**Originality:** All work must be original for this class. Work done for other classes will not be accepted. Information that is not the student’s original work must be documented by citing the source using APA 7<sup>th</sup> edition.

**Submission Format:** Unless otherwise noted, all assignments must be submitted **electronically** on CANVAS uploaded in student folder **on or before the due date by 3:00pm**. Each assignment must be submitted as a single WORD document. The top page of each paper must have name, date, course number, and assignment name.

**Timeliness/Late Work:** One point or one letter grade will be deducted from the assignment grade for each day that work is submitted late (see rubrics). A failing grade, or an incomplete will be given for noncompletion.

## Emergency Procedures

- (c) Forges or falsifies academic documents or records;

(2) Examples of academic misconduct include, but are not limited to:
