Course Description: This course is designed to provide candidates with the knowledge and skills needed for measuring, evaluating and assessing outcomes in the psychomotor, cognitive, and affective domains for students K-12. Special emphasis will be placed on assessment related to SHAPE Content Standards, creating rubrics, and using technology in teaching K-12 physical education.

Course Objectives: (using InTASC standards for teachers)

- Standard 6 Communication The teacher uses knowledge of effective verbal, nonverbal and media communication techniques to foster active inquiry, collaboration, and supportive interaction in the classroom.
- **Standard 7 Instructional Planning •** The teacher plans instruction based upon knowledge of subject matter, students, the community, and curriculum goals.
- Standard 8 Assessment The teacher understands and uses formal and informal assessment strategies to evaluate and ensure the continuous intellectual social, and physical development of the learner.

Boundaries & Expectations for Students

1. Get involved and immersed in class discussions and learning activities. They are important to your success as a teacher. I expect to hear from everyone at least once per class period.

2. Be prepared by reading all assigned readings and completing all assignments listed in <u>Block Plan &</u> <u>Student Calendar</u> and/or D2L. Assessments will be frequent; some will be informal, some formal, some will be in the form of class discussion and sharing ideas.

3. Being present for class activities will greatly enhance your learning. Therefore attendance is required for this course. Since this class is 2.5 hours long missing one class is like missing two normal length classes. Attendance is recorded for each student. See Attendance Policy for more details.

4. Please create a climate suitable for learning by turning off phones prior to class starting. If <u>unauthorized</u> phone use is noted, it will decrease the overall grade by 1% each violation. (This is your notice: teacher is not obligated to tell you about phone use violation as it often creates further disruption to learning.) *When in doubt ask if it is an appropriate time verbally or nonverbally.

5. Students should conduct themselves as if they are already teachers in the field. Please, be prepared, dress appropriately, use appropriate language/vocabulary, treat others with kindness and respect, give priority to people rather than technology, participate regularly, and speak so all can hear when addressing the whole group.

Likewise, tardies may affect a percentage of your final grade. Please turn off phones upon entering the class. Unauthorized phone use will result in 1% decrease to your overall grade.

4. **Work Policy**: Deadline extensions may be available if you request them<u>at least 24 hours before the deadline</u>. Work submitted after the deadline without an extension will be reduced as follows:

- Submitted up to 24 hours after deadline: reduced by 5%
- Submitted 24-48 hours after deadline: reduced by 10%
- Submitted 48+ after deadline: F (automatic 55% if submitted; zero if not submitted)

For Group assignments all receive the same points for the group aspects not including peer evaluations. All computer generated work should include APA style citations. In text citations= (author, text) and end of text citation= references listed. Students may not plagiarize.

By participating in these assignments, you are giving consent to sharing of your work with others in this class and you recognize there is a small risk of your work being shared online beyond the purposes of this course.
