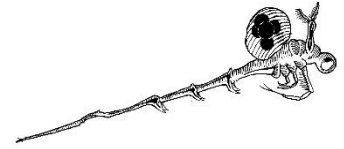


# Exotic and Invasive Species (WATR/NRES 324), Spring 2023

**Description:** Biotic and abiotic factors influencing invasions of native and exotic species including social, political, and economic concerns.

**Learning outcomes:** After completing this course, students will be able to describe the spread, impacts, evolution, ecology, and control of non-native species.

This multidisciplinary course takes a critical look at the perception and management of non-native species and will challenge many of your preconceptions.

**Required Course Materials:** Via textbook rental - "Invasion Ecology" 2<sup>nd</sup> ed. by Lockwood, Hoopes, and Marchetti.

**Grading:** Exam 1 (100 pts), Exam 2 (100 pts), Exam 3 (final exam, 100 pts), and presentation (30 pts). Optional assignments may also be offered throughout the semester.

**Letter grades:** Grades are rounded to the nearest whole percent. For example 89.51% = A- while 89.49% = B+.

## FERPA

The Family Educational Rights and Privacy Act (FERPA) provides students with a right to protect, review, and correct their student records. Staff of the university with a clear *educational need to know* may also have to access to certain student records. Exceptions to the law include parental notification in cases of alcohol or drug use, and in case of a health or safety concern. FERPA also permits a school to disclose personally identifiable information from a student's education records, without consent, to another school in which the student seeks or intends to enroll.
