Course Description, Overview And Objectives

This course is an overview of central topics and analytic domains in Intercultural communication. In studying intercultural communication, we start off by problematizing (i.e., ‘digging in to’) the taken-for-granted concepts of ‘culture’ & ‘intercultural’. We will then see that intercultural communication is occurring much more than we might imagine; indeed, to various degrees we are surrounded by it. (For example, doctors talking with patients (or car mechanics talking with customers) are regularly speaking across the ‘intercultural gulf’ that separates them from ‘lay-people’). We will also study the ways people manage to make their way (successfully, or not) through intercultural encounters. In a deep sense, this course will be about how people avoid, or fall in to, traps of misunderstanding in communication, and how they then work to repair those misunderstandings.

At the conclusion of the course you will be able to:

Identify & analyze aspects of culture in communication.

Identify the key components found within one or more cultures that are distinct from those found in predominantly English-speaking cultures.

Analyze key forces or processes that contribute to global interconnectedness, and their implications.

Demonstrate curiosity and empathetic insight about diverse cultural perspectives.

Program Competencies for the Division of Communication

By the time they graduate, students should be able to:

1. communicate effectively using appropriate technologies for diverse audiences;
2. plan, evaluate and conduct basic (quantitative and qualitative) communication research;
3. use communication theories to understand and solve communication problems;
4. apply historical communication perspectives to contemporary issues and practices; and
5. apply principles of ethical decision making in communication contexts.

In this course we will address *aspects of* all of the above competencies.
